Such unwelcome sexually determined behavior as physical contact and advances, sexually colored remarks, showing pornography and sexual demands, whether by words or actions. Such conduct can be humiliating and may constitute a health and safety problem; it is discriminatory when the woman has reasonable ground to believe that her objection would disadvantage her in connection with her employment, including recruitment or promotion, or when it creates a hostile or offensive working environment.

- ❑ submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment;
  - ❑ submission to or rejection of such conduct by an individual is used as the basis for employment decisions affecting such individual.

  - ❑ such conduct has the purpose or effect of unreasonably interfering with an individual's work performance or creating an intimidating, hostile or offensive working environment.
